- 1) Go to <a href="https://studentaid.ed.gov/sa/fafsa">https://studentaid.ed.gov/sa/fafsa</a>.
- 2) Enter your login information.
- 3) Select the option to "Make FAFSA Corrections".
- 4) Go to the section where you've listed colleges and add the new schools. If you've already listed ten schools on your FAFSA, you'll need to delete some to make room for any new school codes.
- 5) Hit Submit.

6) Follow up! Check your email and/or home mailbox to respond to any requests for materials from these additional schools.

## **FAFSA Verification**

Some FAFSAs are selected for verification. This process requires students to submit additional documents (citizenship papers, tax transcripts, proof of income, etc) to financial aid offices in order to support information entered on the FAFSA. Please make sure to check your email for any requests and respond in a timely manner. Ignoring requests for documents will hold up your financial aid awards.

## **CSS Profile**

Students only need to submit the CSS Profile if it is required by one or more of the colleges they are applying to.

- 1) Log in to collegeboard.org. Each student should already have an account.
- 2) Scroll down and on the right side under "Student Tools," click on CSS/Financial Aid Profile, Apply Now
- 3) Next to Fall 2019 or Spring 2020 click on "Sign In"
- 4) Sign in using the same password as the collegeboard account
- 5) In the left corner, click on Register for PROFILE (You don't have to click on "Click here before you begin")
- 6) Click on "Register"
- 7) After completing the registration, complete the Profile Application. You don't have to complete the "Pre-Application Worksheet"
- 8) **FEE**: The application fee and the fee for up to 8 colleges will be waived for students who have received a fee waiver for the SAT. (For older students, fee waivers will be dependent on the AGI entered on the CSS form.)

## **Common Questions**

Who is my parent according to the FAFSA®?

- If you need to report parent information, here are some guidelines to help you:
- If your legal parents (your biological and/or adoptive parents, or parents as determined by the state—e.g., a parent listed on your birth certificate) are married to each other, answer the questions about both of them, regardless of whether your parents are of the same or opposite sex.
- If your legal parents are not married to each other and live together, answer the questions about both of them, regardless of whether your parents are of the same or opposite sex.
- If your legal parent is widowed or was never married, answer the questions about that paren

## What if my parents are divorced or separated?

- Divorced or Separated Parents Who Do Not Live Together
  - If your parents are divorced or separated and don't live together, answer the questions about the parent with whom you lived more during the past 12 months.
  - If you lived the same amount of time with each divorced or separated parent, give answers about the parent who provided more financial support during the past 12 months or during the most recent 12 months that you actually received support from a parent.
- If your **divorced** parents live together, you'll indicate their marital status as "Unmarried and both parents living together," and you will answer questions about both of them on the FAFSA.
- If your **separated** parents live together, you'll indicate their marital status as "Married or remarried" (NOT "Divorced or separated"), and you will answer questions about both of them on the FAFSA.

#### What if I have a stepparent?

- If you have a stepparent who is married to the legal parent whose information you're reporting, you must provide information about that stepparent as well.
- EXCEPTION: The FAFSA asks about your parents' education level. For these two questions, your parents are considered to be your birth parents or adoptive parents—your stepparent is not your parent in these questions
